Terms and conditions:-

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. The candidate must have minimum qualification of VIII standard pass and those who have passed HSSLC or above shall be ineligible to apply for the said posts.
3. Candidates must have a valid Employment Registration Number for the State of Assam and the Registration must be valid as on the last date of submission of application form.
4. The candidate should not be less than 18 years and not more than 40 years of age as on 01.01.2026. Age relaxation will be as per Govt. Norms for reserved categories in pursuance of Govt. O.M. No. ABP.6/2016/51, Dated 2nd September, 2020.
5. Applications should reach the Office of the undersigned on or before 25.06.2026 during office hours. The appointing authority shall not be responsible under any circumstances for any postal delay.
6. NO T.A./D.A. will be admissible for appearing in interview/viva-voce.
7. Canvassing directly or indirectly will disqualify the candidature.
8. If any candidate is found to have suppressed his/her educational qualifications or given wrong information, at the time of applying for job or later on, his/her candidature shall stand rejected without any information to him/her with immediate effect and shall also be liable to Criminal Prosecution as per Law.

The candidates may also submit their applications in the **drop box** placed at the Office of the Chief Judicial Magistrate, Tinsukia, Assam.
2. The candidates have to mention their up-to-date employment exchange registration number along with the date in the application.
3. The applicants shall mention their contact/Mobile Numbers in the application form without fail.
4. The candidates have to submit self-attested photocopies of all relevant testimonials of educational qualification, age, experience, caste, employment exchange certificate, etc., and two recent passport size photographs along with the application.
5. Candidates must submit self-declaration regarding his/her latest qualification.
6. Candidates already in service should have to apply through proper channel.
7. A candidate will be eligible to apply only for one particular category of post.
